Do you acknowledge that your business invoices Campbell Arnott's directly / operates under your own Safety Management System (SMS)?	Subcontracting companies do not need to register their company. Direct contracting companies will instead register their subcontractors' individual workers.
Has your company been appointed as a Principal Contractor?	A principal contractor is a person conducting a business or undertaking that commissions a construction project. A construction project is a project where the cost of construction work is \$250,000 or more in QLD, NSW or VIC or \$450,000 or more in SA.
Is your company certified to the AS/NZS 4801 or OHSAS 18001 International Safety Management System standard?	This certification is not a requirement of this process and very few companies hold this certification. If you select Yes, you will later be asked to provide a current Australian/New Zealand Standard 4801 or OHSAS 18001 Compliance Certificate showing a JAS/ANZ stamp.
